



INDIA E-VISA INFORMATION

PLEASE READ THE FOLLOWING INSTRUCTIONS CAREFULLY:

Wendy Wu Tours are now completing India E-Visa Applications online to make the process easy for passengers & travel agents alike. Please read the following information carefully:

Step One (Passenger or Agent)

- Send us the following via email:
 - Information sheet below
 - Clear Colour Passport Copy
 - 5cm x 5cm (square size) photo in JPEG format (needs to look like a passport photo, but can be taken with a phone or camera - see next page for more information) Email the above to: documentation@wendywutours.com.au & include booking number.

Step Two (Wendy Wu Tours)

• At 60 days before departure Wendy Wu Tours will complete the online E-Visa application.

Step Three (Wendy Wu Tours)

• E-Visas will be sent back with Final Documentation.

Please note: NO physical passports need to be sent to us for an India E-Visa.

E-VISA PHOTO INFORMATION:

- Must provide one colour, passport-type photograph that meets the following strict criteria:
 - o Taken within the last three months & different from passport
 - Against an all-white background
 - Printed on high-quality photo paper
 - Must be 5cm x 5cm (square size)
 - Provide the full frontal view of your head with your face centred in the middle
 - \circ Include the top of the shoulders and displaying a neutral (non-smiling) expression
 - You may wear neither eyeglasses nor headwear, except for religious purposes

IMPORTANT INDIA E-VISA INFORMATION:

- If the applicant was born in India, please advise us as there may be further documentation required
- If you are currently a citizen of, born in, or held a passport of; one of the following countries, further documentation may be required:
 - o India
 - o Afghanistan
 - o Bangladesh
 - o Iraq
 - o North Korea
 - o Pakistan
 - o Sri Lanka
 - o Sudan
- Once the E-Visa application is sent off, the approval of a E-Visa application is out of our control and an application can:
 - Be rejected by a Consulate without any explanation
 - Take longer than expected
 - Require further documentation
 - Require an actual applicant to come in for an interview
 - Require additional fees
- Consulates are strict about the presentation of passport photos and passports entered in the E-Visa application portal and may be rejected if not neat & clear.
- If you require more than 2 entries over a 1 month period, please contact us to discuss further Visa options.
